The final voting list as per data provided as of November 2023, by the SBIOA has been placed on official website of SBIOA i.e. [www.sbioaahmedabad.org](http://www.sbioaahmedabad.org).

**Important Notes:**

1. The election will be for all the Posts (except declared elected) as hitherto approved by various resolutions and bye laws of SBIOA Ahmedabad. The election will take place for all the existing posts and voting pattern will remain as per detailed Circular SBIOA/EC/1 dated 26.10.2023.
2. Tentative specimen of ballot paper for each post containing Serial Number, Name of Candidate and PF Index is also placed on the website of SBIOA.

**Important Point for candidates:**

1. The candidate(s) will continue to contest election for the post(s) for which he/she has applied, irrespective of his/her place of present posting. The detailed list of the candidates for various post has already been released vide circular SBIOA/EC/04 dated 18.11.2023.
2. Transfer of the candidates will not alter their area of jurisdiction and will not alter their post for which they have applied, however, cluster of voters may change.



### **Important Point for voters:**

1. Voters must be a member of SBIOA – Ahmedabad circle as on 30.11.2023 and also on the date of election. Retired members as on 22.12.2023 are not eligible to vote.
2. The members willing to cast their vote at the other centre/region due to deputation etc. or any other genuine reasons may send their request to the Chairman of the Election Committee as per Annexure A. Such representation will be examined by the committee. Decision of the committee will be final and binding to all in the matter.
3. The casting of votes will be allowed only after identity is verified on the basis of the identity card/valid photo ID like Driving License or Aadhar card of employee.
4. All members are requested to verify their names appearing in the voters list.
5. If they find any discrepancy, they are requested to bring it to the notice of the Chairman of the Election Committee.

### **MODALITY OF CASTING OF VOTE**

The election shall be done by a secret Ballot of single Non-Transferable Vote and every eligible voter shall be allowed to exercise his/her vote at pre-decided venue, date and time. The members whose name appears in voters list of particular booth will be allowed to **VOTE ON THE SPOT AT THE VENUE**. In exceptional cases, members transferred at a place recently and or posted for administrative reasons i.e. on long deputation/auditors will have to take prior permission from the competent election representative / committee member to cast their vote.

### **Process of Vote on the spot:**

1. The members who wish to vote have to arrange himself / herself to reach within the pre-decided date and time at the pre-decided venue. He / She must carry PF Index number to locate the name in the Voter's List.
2. The members should bear the Identity card issued by Branch / BPR unit head / Introduction letter issued by the Branch / Department head, duly signed with the SS No. / Valid Photo ID for verification of members in the voter list.
3. The casting of vote will be marked with the pen / writing instrument placed on the spot and members will be guided by the election officers.
4. To cast the vote, the members have to mark (X) **REPEAT Mark (X)** at the place given in the ballot paper provided for each of the post with the pens specified for this marking purpose and kept at booth. Marking of "X" in excess of specified number of posts will be considered as invalid vote for that post.
5. Scratching cum overwriting (alterations) of marking 'X' in ballot papers will render the vote as cancelled / null and void for that post.



6. Visually Impaired / OH / injured member may be allowed to accompany for voting inside the booth with family member or award staff member with photo ID / Identity card. **(Not with any officer)**
7. Members are advised to visit our website [www.sbioaahmedabad.org](http://www.sbioaahmedabad.org) to get recent updates of election process and circulars.

**CODE OF CONDUCT DURING THE PERIOD OF ELECTION PROCEEDING:**

1. It is our moral duty to maintain the code of conduct and discipline as a member of Association and our beloved institution.
2. All members should adhere to discipline as per SBIOSR.
3. All members should maintain decorum during meetings, gatherings, voting and counting so as not to cause inconvenience to fellow staff members or customers visiting in the branch premises.
